- ❖ **Your FIRST tuition payment and fees will be due August 1st (minus any deposits)**
- ❖ If you would like to pay in TWO payments your 2nd payment will be due November 1st. We will bill you in October.
- ❖ **If you would like to make monthly payments all payments must be received by the first of the month. A valid copy Visa or Mastercard must be provided, which The Studio Atlanta Dance will keep on file. You will NOT receive monthly invoice.**
- ❖ You have a grace period of 15 days (7 days for monthly accounts). After that, a \$20.00 late fee is applied for all overdue balances.
- ❖ **ALL 3-4 yr and up dance classes participate in a recital held in May.**
- ❖ No DANCE RECITAL FEE for 2 ½ - 3 yr classes. We will have an "In-Studio" performance at The Studio.
- ❖ **Makeup classes are available, however; tuition will not be prorated or refunded for absences. Staffing and operational expenses are arranged on the basis of anticipated enrollment levels and are not eliminated when a child is absent.**

WITHDRAWAL POLICY AND WAIVER OF LIABILITY

- ❖ I understand that I am registering for the nine-month contract year which is September 2012 – May 2013.
- ❖ **I understand my tuition and fee amounts and will make timely payments.**
- ❖ I understand that if I don't make timely payments, my child/children will not be allowed to attend class until my account is current.
- ❖ **If I must withdraw after the school year begins, I am required to give a notice four weeks prior to the date of an early withdrawal. Tuition is payable through the four weeks.**
- ❖ I understand that The Studio Atlanta Dance does not issue refunds; however, a Studio credit may be shown on my account for future classes only. Staffing and operational expenses are arranged on the basis of anticipated enrollment levels and are not eliminated when my child withdraws. No credit will be issued if proper notice of drop is not given. Credit good for 1 (one) year only!
- ❖ **I understand that The Studio Atlanta Dance reserves the right to cancel a class if minimum enrollment is not achieved.**
- ❖ I understand that The Studio Atlanta Dance reserves the right to refuse, transfer or terminate enrollment at any time. No liability is assumed by The Studio Atlanta Dance or its staff on behalf of the student for any accidental injury caused by acts of said student or acts of one student to another student. The person hereinafter signing the contract on behalf of said student thereafter assumes responsibility for any such injuries.
